3. All Tenders/bids shall be accepted only through online mode and no manual submission of the same shall be entertained.

4. The tenders/bids shall be opened online at the O/o the Managing Director/Secretary, Kerala Rural Employment and Welfare Society, Thiruvananthapuram on the prescribed date and time.
5. Tenders/bids must be quoted in English language only.
6. The Tenderer should remit an amount **Rs 9000/-** (including GST) as Tender submission fee.
7. **Supply should be completed before 10 days**
8. The rate quoted will be **valid for 3 months**. The rate quoted must be written both in figures and words and it must be firm for the supply period.
9. The rates and conditions should be clearly stated in respect of the item.
10. Online tenders/bids are to be accompanied with a preliminary agreement executed on a Kerala Stamp Paper worth Rs.200/- The scanned copy of the preliminary agreement duly signed by the contractor shall be submitted online.  
Subsequently the original should be submitted in a separate cover through registered post/speed post or physically to this office on or before the date and time of opening of the tender/bid. Tenders/bids received online without scanned copy of the preliminary agreement not submitted and the original in a separate cover by registered/speed post or physically subsequently will not be considered and shall be summarily rejected.
11. Each Tenderer shall remit Rs. 50000/- as Earnest Money Deposit.
12. Rate quoted should include delivery at our depots at Kanjikode Palakkad and Kalliyoor Thiruvananthapuram.
13. The supply should be made after putting each set of books in item 1, 2 and 3 in bundles. The number of books to be contained in a bundle and number of bundles earmarked to each depots will be informed in due course.
14. All rules and regulations of the Tender/bid shall be in accordance with the **Store Purchase Manual** of the Govt. of Kerala. An Offer in Hard Copy which is not reflected in the BOQ will not be considered at any cost.
15. The successful tenderer will have to execute an agreement deed in the prescribed format on a Kerala Stamp Paper worth **Rs 200/-** for the due fulfillment of the contract after depositing 5% of the contract value as Security Deposit.
16. The undersigned has every right to amend/cancel the full or part of this Tender Notice.
17. No compromise will be allowed on qualities of printing/ Paper products. If GSM or other qualities were found less (No tolerance on GSM) on the supplied item strict penal action will be taken against the tenderer including nonpayment of delivered item.
18. All disputes are subject to jurisdiction on courts only at Thiruvananthapuram.
19. The tenderer should quote rate for each item and should supply all items.
